3. IMPLEMENTATION

4. INTELLECTUAL PROPERTY

Intellectual property rights of work carried out at each partner institution shall normally vest with respective institution.

5. DURATION AND RENEWAL OF AGREEMENT

This Memorandum of Understanding will become effective immediately after signature by the representatives of both Tathagat Teachers' Training College, and the Al-IQRA Teachers' Training College, Govindpur Dhanbad, for a period of 3 Years and is subject to revision of modification by mutual agreement.
